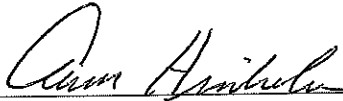

1. **Call to order:** The regular meeting was called to order by Chairman Aaron at 7:00 p.m. in the board room in the Auxiliary Gym.

 - **Review/Approval Policy Updates:** Jon stated that this is the second reading of the updated policies. These changes are mainly from ISBA through their legal department. Jon has added a few additional comments on several of the policies. *Pat moved to approve the policies, seconded by Tara, motion carried unanimously.*
