


COTTONWOOD JT. SCHOOL BOARD MEETING

 - **Approval of Paraprofessional, Head Cook and Janitor:** *Gus moved to approve the following hires: Cara Duman as Paraprofessional, Sharon Deimler as Head Cook, Shelly Sanford as Janitor, seconded by Pat, motion carried unanimously.*
